## Protection of fire-fighters

## 6. Accidental release measures

### Personal precautions - For non-emergency personnel

Do not touch or walk through spilled material. Floors may be slippery; use care to avoid falling. Put on appropriate personal protective equipment.

### Personal precautions - For emergency responders

### Environmental precautions

Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).

### Large spill

Immediately contact emergency personnel. Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations. Dispose of via a licensed waste disposal contractor.

## 7. Handling and storage

### 7.1 Handling

#### 8.2.1.1 Respiratory protection

#### 8.2.1.4 Skin protection
